The Agawam Liquor License Commission held their monthly meeting on Wednesday, June 20, 2018 at 6:30 p.m. at the Agawam Public Library, 750 Cooper St., Agawam, MA 01001. Chairman Kenneth Largay, Commissioner Vin Ronghi and secretary, Maggie McCarthy were in attendance.

The meeting was brought to order and minutes from the April 28, 2018 meeting were approved and accepted.

A public hearing was held for The Quest, Inc. dba Catch 1251, 1251 River Rd., Agawam for an application received to alter the premises. Matthew Gibbs, manager, was in attendance. Catch 1251 would like to close the licensed area above their main dining room and extend their current liquor license to include the outdoor patio area. Concerns were brought up regarding the proper permits for the existing patio and Mr. Gibbs was instructed to meet with the Building Inspector, Erik Wight to get the necessary permits. Approval was granted pending the receipt of these permits.

A public hearing was held for an application received for a change of manager at K&P Welker, Inc. dba Club One, 60 North Westfield St., Feeding Hills, from Kurt Welker to Martin Fullwood. Mr. Fullwood was in attendance and answered any concerns from the board regarding hours, entertainment and "Tips" certification. Transfer of manager was approved unanimously.

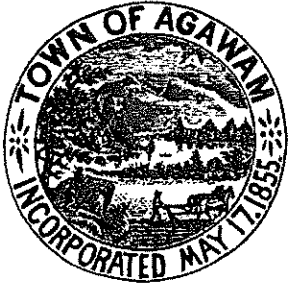
Discussion was held with John G. Kudlic regarding the status of his liquor license for The Headquarters, 485 Springfield St., Feeding Hills. Mr. Kudlic assured the Board that the license is currently being sold and will stay at its current location. The buyer of the license is working on obtaining his LLC and a food license.
