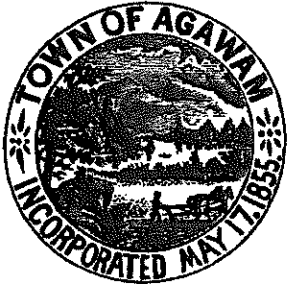

The Agawam Liquor License Commission held their monthly meeting on Wednesday, July 18, 2018 at 6:30 p.m. at the Agawam Public Library, 750 Cooper St., Agawam, MA 01001. Chairman Kenneth Largay, Commissioners Vin Ronghi and Howard Safford and secretary, Maggie McCarthy were in attendance.

A public hearing was held for an application that was received for a change of manager at the Agawam Municipal Golf Course, 128 Southwick Road, from Anthony A. Roberto, III to Thomas J. DiRico. Mr. DiRico was in attendance and stated that he will be present at the golf course 40+ hours per week. He was advised that any occupancy over 99 would require sprinklers to be installed and the board highly recommends that all staff be TIPS certified. Application was approved unanimously.

A public hearing was also held for an application received for a transfer of license, change of location and change of manager from Chagnon, Inc. dba Lineage Italian Bistro, 525 Springfield St., Teraesa Chagnon manager to Macho Taco, LLC, 67 Springfield St., Jose A. Diaz, manager. Mr. Diaz was in attendance and informed that he would need a certificate of occupancy signed by the Building and Fire Inspectors as well as liquor liability insurance if transfer were approved. Application was approved unanimously.
