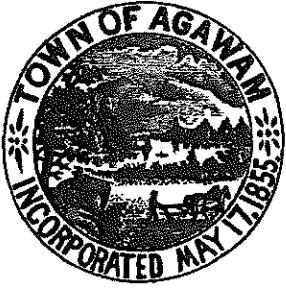

The Agawam Liquor License Commission held their monthly meeting on Wednesday, September 27<sup>th</sup> at 6:30 p.m. at the Agawam Public Library, 750 Cooper St., Agawam, MA 01001. Commissioners Vin Ronghi and Howard Safford and secretary Maggie McCarthy were in attendance.

Minutes from the July 18, 2018 meeting were approved and accepted.

A public hearing was held for a transfer of license and change of manager form DKJ, Corp., dba The Headquarters, 485 Springfield St., Agawam, John G. Kudlic, manager to Agawam Beverage Company, LLC dba POUR, Robert W. Manning, manager.
