Mr. Kozloski called the meeting to order at 6:00 PM.

1. 6:00 PM – REQUEST FOR DETERMINATION OF APPLICABILITY – 187 Clover Hill Drive - Quinby

Mr. Kozloski explained that the applicant is proposing to install a pool. Mr. Quinby said that the main consideration was a non-certified vernal pool. He wanted to be sure the Conservation Commission was satisfied before applying for a permit with the building department. Mr. Kozloski noted that there is a wetland within 100' and the work will include taking down a tree on the left side of the lot. Mr. Quinby said that the large oak tree to be removed will be outside of the 100' radius.

Motion was made by Mr. Meagher and seconded by Ms. Galiatsos to issue a Negative Determination of Applicability – 187 Clover Hill Drive - Quinby.

2. 6:15 – REQUEST FOR DETERMINATION OF APPLICABILITY – 42 Warren Street – Hollander

Mr. Kozloski said that he and Mr. Meagher were on site today. He explained that Mr. Hollander plans to move the existing shed out of the flood plain. Mr. Hollander concurred saying he intends to move the shed to the middle of the property out of the flood plain. Mr. Kozloski said the Commission could give a negative determination because he is out of the flood plain and no longer under the jurisdiction of the Commission.

Motion was made by Mr. Meagher and seconded by Ms. Galiatsos to issue a negative determination of applicability as long as the building remains out of the flood plain.

Mr. Kozloski said that there is a special permit for an agricultural area here so this is still a farm. He said some of the Commission members were on site a few days ago. He explained that they are asking for a Certificate of Compliance that all the work is completed. Mr. Meagher said on the site visit they saw plantings and the grass is growing.

He went on to say that on the plans, part of the property has a drainage easement. He said that Engineering is concerned about the drainage that goes through the property. He added that work may be required to be done.
